### Athletics Carnival Yr 3 - 6

Dear Parents,

Rosemeadow Public School will be holding our Athletics Carnival on **Wednesday 21<sup>st</sup> May 2025** at Campbelltown Stadium.

#### Arrive at Rosemeadow Public School: 8:15am.

Transport: Students will be transported by bus from school at 8:45am

Start Time: 9:30 approx.

Where : Campbelltown Athletics Centre, cnr of Rose Payten Drive and Pembroke Road, Leumeah

Cost : No cost (school is covering \$6000 to provide this opportunity for students)

What to bring : Students should wear their house sport shirt and bring a hat, jumper/ jacket, suitable footwear, lunch, recess, a drink bottle and any asthma medication.

#### Students may wear spikes if they have them for 100m, 200m and long jump.

There will be NO Canteen available on the day.

This is a school event and all students are expected to attend and participate in the activities.

Any Year 2 students who are 8 years old or turning 8 this year may attend ONLY IF they intend to participate. A separate note will go home for these students.

# As part of the carnival, an 800m race for all ages will be held prior to the rotational activities. Marshalling for this event will begin at **8.30am**. <u>Students that are competing in this race will need to make their own way to the stadium</u>.

#### Accident insurance information

- In the event of injury, no accident or medical insurance cover is provided by the NSW Government Treasury Managed Fund for students participating in school sporting activities, physical education lessons or any other school endorsed activity, unless there is a breach of duty of care by department or school staff. The NSW Department of Education is insured to meet the financial impact of any legal liabilities arising from its activities. It does not provide, nor has it ever provided, accident or medical insurance for students enrolled in government schools.

#### Concussion management

- When a student enrolled in a government school is diagnosed with concussion, the principal must be advised in writing as soon as the diagnosis is confirmed. Students may only return to sport and physical activity once a medical clearance has been provided to the school and, if at a school sport event, to the supervising teacher. Any student that experiences a suspected concussion during a school-endorsed activity, will be removed from the activity and parents/carers will be advised that a medical follow-up is required.

If medical clearance is not provided, the student cannot participate in vigorous or competitive school sport or physical activities for 21 days from the concussion date.
